LETTER OF RECOMMENDATION

I would like to give a very enthusiastic recommendation for Aashima Khanna, a Class 12 student from Delhi Public School, R.K Puram and a resident of the constituency I represent in the Delhi legislative assembly.

In July of this year, Aashima approached me with a vision to push a social campaign on dental, mental and general health.

The insights produced from Aashima's campaign have been a revelation for me as a legislator of the constituency. For example, the data shows that 49 per cent of girl students do not exercise. Another alarming insight is smoking among a small fraction of boy students. I am forwarding her report along with data to the Deputy Chief Minister of Delhi, Mr Manish Sisodia who also holds the education portfolio in the Delhi government. I believe insights from Aashima's campaign can bring more health parity in the schools in Delhi.

One of the most revealing insights of Aashima's campaign lies at the intersection of the Delhi government's health policy and students. Delhi government has opened 'Mohalla clinics' in every locality to promote public health. However, data from the campaign shows that only a limited number of students use the same. It has been brought to my knowledge through this campaign that conflict in school timing and clinic time is the reason for this. I assure Aashima's team that I will personally take up this issue with the Chief Minister of Delhi and resolve this at the earliest.

Aashima is an affable, hardworking and determined citizen of my constituency. She has the virtues of an abled team leader and is confident about her visions and planning. She has worked smoothly and in a collegial manner, but also maintains a very strict work ethic and discipline. I appreciate the professional manner in which she has dealt with bureaucracy and school administration and her warmth and sincerity in working with the students. I am deeply thankful for putting her vision and campaign in my constituency.

I can endorse the collaborative skills of Aashima in bringing together various organizations and three government schools to execute the project.
